

What are ADA wall mounting standards?

Wall mounting standards refer to where wall signs are placed. The ADA requires the following: Room designation signs need to be mounted on the latch side of a door. ADA sign mounting height requirements state that signs need to be mounted at least 48 inches from the ground but no more than 60 inches.

Where should ADA Signs be mounted?

For double doors with one active leaf, mount the plaque on the inactive leaf. ADA signs are wall-mounted next to the appropriate door, on the door handle side of the door, 3" from the door jamb and 48" to 60" from the finished floor to lowest or highest line of sign text.

What are ADA exterior signs?
