

How to enable cabinet electricity certificate

Do you need a certificate of approval for electrical equipment?

Under the Electricity Regulations 1994, certain categories of electrical equipment require a Certificate of Approval (CoA) from ST before they can be manufactured, imported, displayed, sold, or advertised. This regulation applies to: Domestic Equipment: Appliances intended for household use.

What is a certificate of registration as an electrical sign contractor?
